



## Privacy Policy

The protection of your personal data is not only required by law, but is also important to us. Our following privacy policy therefore applies to our events. ### 1. Responsible

Responsible as host is the rhein-marathon düsseldorf GmbH Rathausufer 10, 40213 Dusseldorf. If you have any questions about data protection, you can always contact us by e-mail at [info@rhein-marathon.de](mailto:info@rhein-marathon.de). This Privacy Policy clarifies participants about the nature, scope and purpose of the collection and use of personal data by the controller, its agent or service provider. The legal foundations of data protection can be found in the Federal Data Protection Act (BDSG) and the Telemedia Act (TMG). The responsible person is obliged to draw up a list of processing activities.

### 2. Purpose of the data collection

For the organization of the event personal data of the participants are collected and processed. We use the stored data exclusively for the respective event. We only forward the personal data to service providers required for the event (for example, medical service, timekeeping service, etc.). Please also read point 3. The collected data will also be used to create the starter list and result list.

### 3. Use of external service providers

For certain tasks, we may commission external service providers with data processing (e.g., data acquisition, timing). These service providers process the data exclusively according to our instructions and are therefore also bound by this privacy policy and are controlled by us. The service providers may not use the data for their own purposes or pass them on to third parties.

### 4. Scope of the data

For the purpose described in point 2, the following personal data are collected:

Last name, first name, gender, date of birth, nationality, address, e-mail address

Without this data, participation in the event is not possible. Further data can be provided, but are not mandatory.

### 5. Duration of data storage

The personal data will be stored from the time of entry by the participant or the recording of a written message by the person responsible and published on the event website in the starter list until the day of the event. In the publicly visible starter list following data are displayed: last name, first name, club (if specified), nationality, age group.

On event day, publicly available result lists will be printed and published for each individual race. These include: last name, first name, club (if available), age group.

After the event, the result list will be published on the event website for at least 2 weeks. This is i.a. a requirement of the German Athletics Association. Following this, the entry can be removed from the publication if desired.
